# TERMS AND CONDITIONS FOR ANNUAL RATE CONTRACT FOR LABORATORY CHEMICALS.

- 1. The Rate Contract (RC) will be valid for one year from the date of issue of order. However, it can be further extended up to 3 months, if required.
- 2. Validity of Offer: The offer must be valid for three months from the date of opening of the quotation.
- 3. Only printed list submitted along with offer will be acceptable to CSIR-CEERI. No upward change will be acceptable under any circumstances. If the price gone down wards during the currency of the Rate Contract, the reduced prices will be charged. The period of currency shall normally by one year.
- 4. As Rate contract shall be placed with only registered and or reputed Indian manufacturers or authorized distributors of manufacturers who are authorized for supplying the stores. You are requested to submit your registration/authorization/distributor certificate along with your quotation.
- 5. Since the time is the essence of the Rate Contract. The purchase order shall be executed within a short period/ fortnight or within delivery period mentioned in CSIR-CEERI purchase order/rate contract. In case, the firm fails to supply the stores within stipulated period CSIR-CEERI reserves the right to not accept the supply, in part or full and to claim liquidated damages @ 0.5% per week subject to a maximum of 5% of the total value of stores ordered.
- 6. CSIR-CEERI is exempted from payment of Excise Duty under notification number 10/97 dated 1.3.1997 and Customs Duty under notification No. 51/96 dated 23.7.1996. Hence Excise Duty and Custom Duty, as applicable on such items falling in the preview of above notifications should be shown separately. The necessary Exemption Certificate shall be issued by CSIR-CEERI on for such items on written request from Vendors. No charges other than those mentioned clearly in the quotation will be paid.
- 7. The rate of Sales Tax, Central Excise Duty etc. should be clearly indicated where ever chargeable. This office is not eligible to issue "C" or "D" Form. However the concessional rate of Central Sales Tax admissible to Research Institutions on purchase of scientific instruments/ equipment etc. from certain State like Maharashtra, Delhi, West Bengal, Tamil Nadu etc. is applicable to this Laboratory.
- 8. Any parallel rate contract for similar items can be placed at any time during the period of rate contract with one or more firms/ manufacturers by the Director, CSIR-CEERI, Pilani.

- 11. The prices should be F.O.R. CSIR-CEERI, Pilani 333 031, Central Store. For any Damages/ Shortage during transit, you/ your authorized dealer / agent will be responsible and the same must be replaced within maximum 5 working days.
- 12. The tender should be submitted along with required EMD of Rs. Two lakh valid for Three months in the form of Demand Draft or Banker's Cheque or Bank Guarantee in favour of Director, CEERI, payable at Pilani to be issued from any nationalized bank. The vendors registered with DGS&D/NSIC as manufacturer for the supply of the same category of Chemicals for which they are submitting the quotation will be exempted from submission of EMD. Such intended vendors shall have to give the request for wavier of EMD along with proof of registration with their respective quotations.
- 13. EMD of the unsuccessful bidders shall be refunded without any interest at the earliest after finalization of the Rate Contract of concerned item.
- 14. The Bid Security/EMD may be forfeited if a bidder withdraws or amends or impairs or derogates its Bid during the period of bid validity.
- 15. Offers received without EMD / Proof of EMD, waiver shall be summarily rejected.
- 16. The material must be supplied in one lot. Part supplies generally will not be acceptable.
- 17. The orders will be placed irrespective of value as per CSIR-CEERI requirement.
- 18. The material will not be supplied by you less than the Rate Contract priced to any other Govt. Institution. If, the same is found the proportionate recovery will be made immediately.
- 19. Kindly issue a certificate stating that maximum discount is being given and no other Govrt. Organization is being benefited more than this discount.
- 20. No upward revision of prices shall be acceptable under any circumstances. In case of downwards revision of prices during the currency of the Rate Contract, the reduced prices shall be applicable.
