

PGRPE-2012 : Short-Listing Result for TS/QHF

“Advanced Semiconductor Electronics” Programme at CSIR-CEERI, Pilani

General Conditions:

1. Engineering graduates of 2011 and the candidates graduating in 2012 have been considered.
2. The candidate's age cannot be more than 28 years as on 01.07.2012. For reserved categories, age relaxation is as per government of India rules.
3. CGPA has been converted to equivalent percentage by a linear method which converts the highest possible CGPA in the system to 100% on the percentage scale
4. Candidates whose final results are awaited were considered provisionally based on their academic performance up to 7th semester.
5. CGPA of 7.00 (out of 10) or 70% marks are necessary for being eligible for the programme.

Short-listing Criteria:

The applicant needs to fulfill any one of the criteria listed in the table below in order to be eligible for appearing in interview.

5.	GATE Score \geq 687	All candidates with <i>valid</i> GATE score.

7.	GATE Score \geq 360	ST category candidates with <i>valid</i> GATE score.
8.	CGPA \geq 7.50 or Percentage \geq 75.00%	Graduates of IITs, IIT-BHU, ISMU, and BITS-Pilani (excluding Dubai campus).

Any applicant to this programme who fulfills the short-listing criteria mentioned above but whose name does not appear in the list of short-listed candidates for interview may communicate immediately (*latest by July 12, 2012*) by email giving complete details of claim to <acsir@ceeri.ernet.in>. If the claim is found valid, the candidate will be allowed to attend the interview with all valid documents on July 21, 2012 or July 22, 2012.

Instructions and Information for Short-Listed Candidates

Short-listed candidates are required to report for interview in the main auditorium at **CSIR-NPL, Dr. KS Krishnan Marg, Near Pusa Circle, New Delhi – 110 012** as per the schedule given below.

Candidates must get their documents verified by reporting at 9.00 AM and 1.30 PM as applicable. **Please note that unsuccessful verification will make a candidate ineligible for appearing for the interview.** The schedule of interviews is as follows :

- July 20, 2012; 9.30 AM to 1.30 PM : Candidates at serial numbers from **1 to 30**.
- July 20, 2012; 2.30 PM to 6.00 PM : Candidates at serial numbers from **31 to 60**.
- July 21, 2012; 9.30 AM to 1.30 PM : Candidates at serial numbers from **61 to 90**.
- July 21, 2012; 2.30 PM to 6.00 PM : Candidates at serial numbers from **91 to 120**.
- July 22, 2012; 9.30 AM to 1.30 PM : Candidates at serial numbers from **121 to 150**.
- July 22, 2012; 2.30 PM to 6.00 PM : Candidates at serial numbers from **151 onwards and any other eligible candidates**.

Any candidate who was an applicant for this programme and whose name does not appear in the list of candidates short-listed for interview, but who fulfills the shortlisting criteria is requested to appear for the interview with valid documents on July 21, 2012 or July 22, 2012 with prior information and approval.

Documents to be brought by the candidates at the time of interview :

Candidates are required to bring following documents with them:

1. Two (2) printed copies of the submitted application form of each programme preference and for each TS/QHF preference as applicable.
2. Two (2) copies of their recent passport size photograph for each programme preference and for each TS/QHF preference as applicable.
3. **Originals** of the following documents and self-attested two (2) photocopies for each programme preference and self-attested two (2) photocopies for each TS/QHF preference as applicable:
 - BE/BTech/B.Sc.(Engineering) degree / provisional degree.
 - BE/BTech/B.Sc.(Engineering) detailed marksheet(s) / transcripts showing the final CGPA/percentage up to eight semesters / 4 years or CGPA/percentage up to seventh semester (where final results have not been announced by the date of interview).
 - Matriculation/secondary school certificate (in support of date of birth).
 - SC/ST/OBC/PH candidates are also required to produce the requisite certificate issued by the competent authority.
 - Valid GATE score card of GATE-2011 or GATE-2012 examinations, if applicable.
 - Diploma pass certificate or BSc degree, if applicable.
 - XII class pass certificate, if applicable.

The above implies the following :

- If you have been short-listed for one programme and plan to appear for TS as well as QHF interviews then you need to get 4 complete sets of self-attested documents with your originals.
- If you are short-listed for two programmes and plan to appear for TS as well as QHF interviews then you need 8 complete sets of self-attested documents with your originals.
- If you have been short-listed for one programme and plan to appear only for TS interview then you need to come with 2 complete sets of self-attested documents with your originals.
- In case you are short-listed for two programmes and plan to appear only for TS interview then you should come with 4 complete sets of self-attested documents with your originals.

Other Information :

1. Selection of the candidates will be based on their performance in the interview.
2. Candidates admitted provisionally to the PGRPE-2012 programme based on their CGPA/percentage results up to 7th semester (pending availability of final result) would have to furnish their final result and percentage/CGPA on or before October 31, 2012 for confirmation of their provisional admission. If they are unable to do so or if their final percentage/CGPA falls below ***the basic eligibility criteria, their provisional admission will stand cancelled.***

Stipend/fellowship as Trainee Scientist (TS) / Quick Hire Fellow (QHF) for provisionally admitted candidates will be released only after confirmation of their provisional admissions.

3. No TA/DA would be payable to candidates for attending the interviews. Please make your own stay arrangements.
4. Note that on joining the programme, ***all successful candidates will be eligible for journey TA as well as TA/DA for attending the interview.***
